

FELONIES BY CLASS IN ILLINOIS



THERE ARE SIX GENERAL CLASSES OF FELONIES IN ILLINOIS, EACH WITH ITS OWN SET OF PUNISHMENTS.



CLASS X FELONIES IN ILLINOIS

PENALTIES: 6 TO 30 YEARS' IMPRISONMENT

EXAMPLES OF CRIMES: AGGRAVATED BATTERY OF A CHILD, AGGRAVATED CRIMINAL SEXUAL ASSAULT, PREDATORY CRIMINAL SEXUAL ASSAULT OF A CHILD



CLASS M FELONIES IN ILLINOIS

PENALTIES: 20 TO 60 YEARS' IMPRISONMENT

EXAMPLES OF CRIMES: CLASS M APPLIES EXCLUSIVELY TO MURDER CHARGES



CLASS 1 FELONIES IN ILLINOIS

PENALTIES: 1 TO 15 YEARS' IMPRISONMENT

EXAMPLES OF CRIMES: CRIMINAL SEXUAL ASSAULT, AGGRAVATED INSURANCE FRAUD, SECOND DEGREE MURDER, AGGRAVATED ROBBERY



CLASS 2 FELONIES IN ILLINOIS

PENALTIES: 3 TO 7 YEARS' IMPRISONMENT

EXAMPLES OF CRIMES: THEFT OVER \$500, CONTROLLED SUBSTANCE TRAFFICKING, ARSON, KIDNAPPING



CLASS 3 FELONIES IN ILLINOIS

PENALTIES: 2 TO 5 YEARS' IMPRISONMENT

EXAMPLES OF CRIMES: SEXUAL MISCONDUCT BY A CUSTODIAN, PERJURY, FORGERY, RECKLESS HOMICIDE



CLASS 4 FELONIES IN ILLINOIS

PENALTIES: 1 TO 3 YEARS' IMPRISONMENT

EXAMPLES OF CRIMES: COMPUTER FRAUD, MOB ACTION, STALKING, OBSTRUCTING JUSTICE, UNLAWFUL POSSESSION OF HANDGUNS

IN ADDITION TO THE IMPRISONMENT TIMES LISTED ABOVE, CHARGES MIGHT ALSO INCLUDE HEAVY FINES FOR THE PERSON ACCUSED OF A CRIME. SOMEONE CHARGED WITH A FELONY MIGHT ALSO EXPERIENCE MANY "COLLATERAL" CONSEQUENCES, SUCH AS LIMITED EDUCATIONAL, EMPLOYMENT AND HOUSING OPPORTUNITIES.
